TERMS OF AGREEMENT: I commit to membership in the Good Life Farms CSA for the 2008 harvest season (May 18th – Oct 26th). I understand that if I fail to pick up my share it may be donated or composted. I understand that I may transfer ownership of my share to another person, but there are no refunds. I understand that I will not be required to work or help distribute to be part of this CSA. I understand that farming is inherently unpredictable and that, while the growers act in good faith to provide fresh, locally grown produce and products, they cannot guarantee quantities or contents of weekly shares. I understand that edible produce grown by Good Life Farms will not be treated with chemical pesticides, herbicides, or fungicides. I understand that corn, melons, and fruit grown on trees are grown on local farms but may be treated with non-organic sprays.

MEMBERSHIP: You are a member when you complete the membership form and full payment is received.

HOW IT WORKS & PICK-UP LOCATION: The season runs 25 weeks from May 18th – Oct 26. During the harvest season, members pick up their share of the week's harvest every Sunday from 11am – 1pm at Sycamore Farm Bed & Breakfast located at 5001 E. Poplar, Terre Haute, IN 47803.

SPLITTING A SHARE & TRANSFERRING MEMBERSHIP: It's ok to split the share, but the whole share must be picked up by one of the splitting members in any given week. How and when you split the share is up to you. Transferring membership is an agreement between you and who you transfer to. Contact me to add them to the list of people allowed to pick up your share.

COST: \$450: Your payment guarantees your membership. Payment should be sent with membership contract.

PAYMENT OPTIONS: Check, Money Order, Cashiers Check made payable to Good Life Farms. Cash will also be accepted but should not be sent through the mail. Receipt of payment will be sent.

PROJECTIONS: Good Life Farms intends to supply approximately 10% more in produce and products than the share price. Ideally, members will receive \$100 worth of extra food by the end of the harvest season.
